Working colleagues at the State University of Haiti and Syracuse University administrators, and faculty and administrators at the Whitman School of Management, College of Engineering, Falk College of Sport and Human Dynamics, and the School of Information Studies, the program brought two cohorts of Haitian students who earned advanced degrees in these disciplines. All of the students excelled in their programs and two students from the first cohort were invited to enter Ph.D. studies in Engineering. The students completed their doctoral degrees with distinction.
