- Note 1: New or Revised Course see description for detailed information.
- Note 2: Limited enrollment offering; may be dropped only during first 5 days of semester.
- Note 3: No Drop Limited Enrollment offering. Students are not permitted to drop course at any time after the last day of the Fall or Spring registration period.
- Note 4: Course eligible for the Pass/Fail option. Courses required for students on the Structured Curriculum may not be taken Pass/Fail. Refer to Academic Handbook Rules 13.4.1-3 for more information.
- Note 5: Course designated to meet writing requirement.
- Note 8: Course offered every other year
- Note 9: Enrollment is limited to L.L.M. students only.
- Note 10: Students may register for up to 30 credits in clinics and externships, excluding the externship seminar, during law school. Only open to students who applied for and were selected for this clinic or externship. Clinics and externships are not drop limited enrollment courses. Students are not permitted to drop the course at any time after the last day of the fall, spring or summer registration period.
- Note 11: See Academic Handbook E 4 (a-f) regarding eligibility for academic credit. Any credit given will be on pass/fail basis only. Students eligible to receive 3 credits may register for 2 hours in Fall and 1 hour in spring or 1 hour in fall and 2 hours in spring. Students eligible to receive 1 credit may register in either fall or spring.
- Note 12: Students may earn up to two fully graded credit hours for independent research under faculty supervision. Satisfactory completion of a two credit independent research project may satisfy the writing requirement provided that the project satisfies the requirements of Academic Rule A(3)(b). LAW 997 only students earning two credits must register for one credit each semester.
- Note 13: Does not meet writing requirement
- Note 14: This course meets the upper class Administrative Law or Statutory/Legislative Course requirement. Review the course description for further information regarding compliance with this requirement.
- Note 15: The credits for this course count toward the satisfaction of ABA Standard 303(a)(3) which requires all College of Law students to satisfactorily complete one or more experiential course(s) totaling at least six credit hours. The credits for this course also count toward the satisfaction of the New York State Skills Competency Requirement for Admission to the Bar. To satisfy this requirement, students must successfully complete 15 credit hours of practice-based experiential coursework
- Note 16: This course is for students enrolled in the JDinteractive program only.
- Note 19: This is a one semester externship. Students must register for 12 placement externship credits and 2 externship seminar credits.
- Note 20: This is a one semester clinic. Students must register for 6 credits.
- Note 21: This is a year-long clinic. Students must enroll for 6 credits in the Fall and 6 credits in the Spring.

Course Notes cont.

Note 22: This is a semester long clinic for 3 credits. Students who have not previously taken a clinic or externship will be given priority in registration over students who have previously enrolled in a clinic or externship.

Note 23: Clinic II - only open to students who have completed the basic clinic course in this specialty area. Enrollment is at the discretion of faculty member and is very limited. Variable credits between 1 and 4, as determined by faculty instructor before start of the semester.

Note 26: Meets with PAI 730, Section 6 (Central Challenges in National Security). Open to third-year law students who have completed National Security Law and/or Counterterrorism Law.

Note 28: 3 hours Fall, 3 hours Spring, must enroll both semesters, will receive grade at end of academic year.

Note 35: LAW 630 will be held on Saturday, October 26, 2019 from 8am-5pm and Sunday, October 27, 2019 from 12:00pm-5:00pm in the Bottar Lecture Hall Room 352.

Note 36: Will receive P/F grade at end of semester. Must also enroll in two credit graded externship placement seminar class. (2 credits = 8 hours/week work; 3 credits = 12 hours/week work; 12 credits = 35 hours/week work). Instructor permission required for registration and in determination of credits.

Note 37: Students who completed NYEx in Fall 2017 are eligible to register for one credit of LAW 920, instead of two.

Note 38: Course will not meet every week. Schedule will be disseminated by instructor.

Note 41: Students can choose either to (i) write a research paper that meets the writing requirement; or (ii) write a series of shorter papers that do not satisfy the writing requirement. Other course requirements will need to be fulfilled regardless of writing option selected by student.

Note 43: 2 credit course with 1 credit option. In order to register for the one credit option, student must meet with Kim Wolf Price, Director of Externship Programs, prior to credit adjustment.

Note 48: LAW 838 - This seminar can be taken for 3 credits over two semesters or for 2 credits in the Fall semester only. Whether taken for 3 or 2 credits, this course may not be dropped after the first five days of the Fall semester. Students taking the seminar for 3 credits may register for 1 credit in the Fall and 2 credits in the Spring, or 2 credits in the Fall and 1 credit in the Spring. Students taking the seminar for 2 credits must enroll only for the Fall semester. Initial enrollment is not permitted in the Spring semester. With permission of the instructor, for students enrolled over two semesters only, the course may satisfy the Writing Requirement. For students enrolled for only one semester, the course will not satisfy the Writing Requirement.

Note 56: Course open to LL.M. and Non-J.D. students only

Note 57: Students taking Law 712 may also be interested in Law 824, Advising the Start Up I with Professor Ghosh. Those taking Law 712 with Professor Ghosh should note the course will cover the topics in the course description but will also make use of web-based communications such as the NY Secretary of State, SEC website, and Bloomberg Law database. Some class meetings with be through pre-recorded classes, make-up classes, and Skype sessions. Grading will be based on online quizzes (about 10 over the semester based on prerecorded lectures; 10%); two midterms (10% each); in-class, closed book final (70 %). Note 58: LAW 824 – this course replaced the old Law 814 sequence for those doing the Curricular Program. This course is also the first part of a sequence, and J.D. students are expected to take Law 825 Advising the Startup II in the Spring to complete the sequence.

Note 59: This course is offered in a condensed format, ending after six weeks. It does require 2-3 Saturday morning commitments in September.

Note 60: Day, time and room scheduling in progress – more information to follow.

Note 62: Capital Habeas Defense: course will meet over two Saturdays, September 14 and 21, 9:00 am – 4:00 PM. Location: Fallon Lecture Hall 106 and Bond Schoeneck & King Courtroom 002.

Note 63: Distressed Dealmaking: course will meet Friday, September 27 from 1pm-5pm, Saturday, September 28 9am-1pm, Friday, October 25 from 1pm-5pm, and Friday, November 15 from 12pm-5pm in Fallon Lecture Hall 106.

Note 64: Emerging Technology: course will meet every other Thursday on the following dates: 8/22, 9/5, 9/19, 10/3, 10/17, 10/31, 11/14.

Note 65: Selecting Your Jury: A hands-on, interactive, intensive two day course on selecting a jury. This course will meet over two Saturdays: October 19 and November 2 from 10 am – 5 pm. Location: Fallon Lecture Hall 106 and Bond Schoeneck & King Courtroom 002.

Note 66: LAW 800: enrollment in this course is for December 2019 graduates or Pro Bono Scholars only. Course is designed to be taken during the semester immediately preceding the bar exam.

Note 67: Course enrollment available only to students who did not already complete LAW 645 Negotiation for Lawyers or LAW 630 Negotiation. Students who already completed LAW 645 Negotiation for Lawyers or LAW 630 Negotiation are not eligible to register for Negotiation Skills.

Note 68: This class will meet on Wednesdays only from October 2 through November 20 from 8:00 am – 9:30 am. The aim of the course is to provide a practical insight into EU-US cooperation in criminal matters. The course is co-taught by Professor Todd Berger and Professor Martyna Kusak from Adam Mickiewicz University in Poznan, Poland. Using an online platform, students from both universities attend class simultaneously. Each class features live lectures by Professors Berger and Kusak as well as participation from students at each institution. The class features unique opportunities for students from both universities to cooperate with their foreign colleagues. Beyond jointly attending class, SU and AMU students will partner with each other while working on a hypothetical case relating to extradition and evidence-exchange between the EU-US.

Note 69: Registration for this course is by permission of instructor only. Course is variable credit (2-3). Dates: August 10-18, and August 24, 2019.
