


How to Complete a Syracuse Law Graduate Survey on 12Twenty

This is very simple after you do it once.

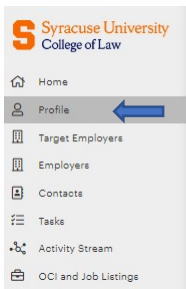
