I. Introduction

Welcome to the "LondonEx" Program!

We are excited to have you join us for a new experience working in London. We look forward to working with each of you as learn more about lawyering in a global world and more about yourself.

Below is an overview of important aspects of the LondonEx program. It outlines student learning outcomes, the orientation schedule, course expectations, and miscellaneous items.

Note: Nothing in these policies should be read to preclude a student from utilizing an approved educational accommodation.

This is the anticipated schedule; it is possible that we will make adjustments and changes to the schedule due to the availability of our speakers and site visits.

II. Student Learning Outcomes

At the end of this course, you should be able to:

- Utilize basic legal skills as are appropriate for your placement setting;
- Comprehend, interpret, and analyze the law related to your placement;
- Speak and write effectively about the law in a manner appropriate to the audience;
- Receive, evaluate, and incorporate professional feedback;
- Reflect upon your experience of the practice of law in an international setting;
- Effectively collaborate with professional colleagues;
- Reflect up and demonstrate an appreciation for the differences in the education and training of lawyers in England, and the impact of these differences on the practice of law and the justice systems;
- Better understand the role of lawyers in England, and the impact of culture on lawyering, professional environments, and legal results;
- Compare what you learn about law and lawyering in England with your knowledge and experience of law and lawyering in the US; and
- Appreciate the important roles lawyers play in society and recognize the impact of law

on people and institutions.

III. Overview of Course

As described below in more detail, the course involves: 1) your placement experiences with your mentors; 2) orientation; 3) weekly seminars; 4) structured learning activities, including site visits and other events in the greater London area; 5) weekly submission of journals and time sheets; and 6) final projects.

You will be spending no more than 50% of your time at your placement, with the remainder of your time on structured educational activities. These include all other components of the course identified above as well as time spent preparing for activities, producing reflective writings, recording best practices, completing time sheets, preparing your final presentation, and structured learning time at your placement (to be discussed during orientation).

Orientation will be from Monday, May 13, through Friday, May 17, pursuant to the schedule set forth below.

Placement activities will begin on Monday, May 20. Students are expected to communicate with their mentors in advance of this date to confirm an initial meeting to discuss expectations and initial work assignments.

Schedules for each week of the program following orientation, detailing seminars, and other events, will be provided during orientation and are subject to change. Generally, such programming will occur on Tuesday and Thursday evenings, from 5:30 p.m. to 8:00 p.m. (dinner will be provided) and most Fridays from 9:00 a.m. to 5:00 p.m.

IV. Course Expectations

A. Placements: You are expected to be at your placements during weekdays (Monday - Thursday) unless you and your mentor have coordinated a different arrangement. On days when your supervisor is not working in the office, you may use the shared co-working space at the SU London Centre.

B. Structured Learning Activities: You are expected to participate in all structured learning activities unless you have a conflict with placement-related activities or extenuating personal circumstances. There are several social activities with mentors and friends of the College of Law that you should plan to attend as well. You may want to note two of these: A Drinks Reception from 6:00 p.m. to 8:00 p.m. on May 22, and a Mentors' Dinner on June 20. More information as to each will be forthcoming.

C. Weekly Seminars: You are expected to be prepared for and to participate in weekly seminars. You will receive updates throughout the program concerning the weekly seminars.

D. Reflective Journal: A reflective journal shall be submitted every week beginning the

first week of your placement. The reflective journal should be of approximately 600 words. It should be submitted to Blackboard by noon every Saturday. You will see a tab called "Journals" on Blackboard, which provides information regarding the required reflective journal and which you should use for your journal submission.

- E. Timesheets: A weekly timesheet submitted via Qualtrics that tracks the amount of time spent in your placement on billable time, learning time, and other time will be due when your journals are due (Saturdays at 12:00 p.m.). More details about timesheets and advice on tracking time will be provided and discussed during orientation.
- F. Best Practices: Because experience is a powerful tool for learning skills, you are required to complete the Best Practices document found on Blackboard. That document will facilitate the conversion of your experiences into usable lessons that you can apply in your future practice. You will need to discuss six experiences from your placement, seminar or other learning activity, and identify the lessons or skills you derive from that experience. You will be asked to share one practice tip with your classmates on our last day of class. The Best Practices document should be completed and submitted by the last day of class through Blackboard.
- G. Final Project: Each student will be expected to deliver a presentation to the class. Presentations should be succinct, engaging, and appropriate to the intended audience. More information will be provided during the program. Presentations are tentatively scheduled for June 28. You should plan to submit a one-page statement about your presentation topic as well as an informal outline in advance of the presentation. More information about the final project will be posted on Blackboard.

In addition, you will be asked to submit a self-assessment of your presentation, reflecting on, among other things, what you learned about the skill of presenting that you will use in future presentations and how well you achieved your goals for the presentation. Additional information about the self-assessment will be provided.

- H. Class Preparation: Students are expected to attend each scheduled activity, seminar, or event and be prepared to discuss the assigned reading, where applicable.
- I. Class Participation: You are required to participate and engage in each scheduled activity, seminar, and event scheduled during the program. Such engagement will facilitate and reinforce your learning. If you are unprepared to participate, you will be treated as absent. We also recognize that an unexpected event may come up that prevents you from being able to participate. Accordingly, we will excuse you without penalty from participating **once** during the summer <u>if</u> you notify one of use prior to class, the event, or activity.
- J. Attendance: Regular and punctual attendance at placements and all academic programs is required as a condition of earning credit for this program. A student may not miss more than 15% of all scheduled structured learning activities and seminars, or placement hours. This rule applies regardless of the reason or excuse for your absence. An exception may be made for someone who experiences an unexpected crisis or disaster and who has not already used up his or her allotted number of absences frivolously. An exception may also be made for a required placement-related

scheduled activity. Please contact one of us to discuss any such situation. In addition, be on time for all seminars and structured learning activities. If you are habitually or excessively late, you will be deemed absent.

V. Course Announcements and Materials on Blackboard

All notices, schedules, supplemental materials and other information and documents for this class will be made available exclusively on Blackboard. You will be deemed to be on notice regarding anything we post on Blackboard. Accordingly, it is important for you to regularly check Blackboard. The Blackboard site that will be used is the one labeled: LondonEx Seminar. The time referenced in any assignment due by a specific time is London time (not EST).

VI. Assessment and Grading

The externship/placement course is 4 credits and is graded on a pass/fall basis, unless your home law school requires a letter grade. Your placement work will be assessed through the following:

- Informal formative assessment by your placement mentors on your legal work; and
- Summative assessment by your placement mentors at the end of the summer term.

The "seminar" portion of the course, which is 1 credit, includes all other learning events and opportunities, and is graded as follows: High Honors, Honors, Pass or Fail. The following will count for grading the seminar:

- Your reflective submissions, including your Statement of Goals (about 40%);
- Your attendance and participation in class and structured learning site discussions (about 15%);
- Completion of Best Practices document (about 15%); and
- Assessment of your final presentation and self-assessment (about 30%).

VII. Learning Environment:

The College of Law recognizes that our individual differences can deepen our understanding of one another and the world around us, rather than divide us. During all of our activities, you will be treated with respect, and individuals of all ages, backgrounds, beliefs, ethnicities, genders, gender identities, gender expressions, national origins, religious affiliations, sexual orientations, and abilities - and other visible and nonvisible differences - are welcome. We encourage you to share your experiences and perspectives with each other and expect all members of the class to contribute to a respectful, welcoming, and inclusive environment.

Morning: Court Observation

Students are expected to visit either the Royal Courts of Justice or the Old Bailey to engage in an observation of public hearings on that day. Please let your instructors know in advance which court you intend to observe. Information for each court is below:

Royal Courts of Justice (RCJ): The RCJ primarily deals with civil (noncriminal) litigation, including cases involving: (i) business, trade, and industry disputes such as intellectual property, professional negligence, and tax matters; (ii) personal disputes such as trusts, wills, and probate; (iii) financial or family disputes such as disputes between vendors, purchasers, landlords and tenants, mortgage actions, trespass, right of way, construction of a lease, and squatters; and (iv) asylum, libel, or deportation hearings.

Students should meet at the SU London Center at 8:45 am to leave bags/electronics, and check in with the LondonEx team. The RCJ (Strand, London WC2A 2LL) beings hearing cases at 9:30 am. Upon arrival to the RCJ, review the Daily Cause Lists and navigate to courtrooms. The court has airport-style security and students are encouraged to leave laptops and large electronics at the Centre before going to the court that morning. Students should disperse and may visit more than one courtroom. Be prepared to reflect on your experience and observations. Bring your ID.

Old Bailey: The Old Bailey, also known as the Central Criminal Court, is a criminal court in London, England that hears the most serious criminal cases in the country. Students should meet at the SU London Center at 8:45 am to leave bags/electronics, and check in with the LondonEx team. The Old Bailey (Old Bailey, London EC4M 7EH) prohibits entry of persons with phones, smart watches, tablets, laptops, and other electronic devices - leave all of this at the London Centre. Be prepared to reflect on your experience and observations. Bring your ID.

Leave your court observation with enough time to arrive to the Centre for a session starting promptly at 11:30.
