Note A: A grading curve course

Note 3: No Drop Limited Enrollment offering. Students are not permitted to drop course at any time after the last day of the Fall or Spring registration period.

Note 4: Course may be taken with the Pass/Fail grading option. See academic rule.

Note 5: Course designated to meet Academic Writing Requirement.

Note 6: Course designated to meet Professional Writing Requirement. Students must complete LCR I and LCR II before enrolling in a course that satisfies the Professional Writing Requirement.

Note 13: JDI Students may register for up to 15 credits in clinics and externships, excluding the externship seminar, during law school. Externships are only open to students who

applied for and were selected for the externship. Clinics and externships are no-drop limited enrollment courses. Students are not permitted to drop the

course at any time after the last day of the fall, spring or summer registration period. Clinics and externships are exempt from the upper class grading curve.

Note 14: This course meets the upper class Administrative Law or Statutory/Legislative Course requirement. Review the course description for further information regarding compliance with this requirement.

Note 15: This course satisfies ABA Standard 303(a)(3) which requires all College of Law students to satisfactorily complete one or more experiential course(s) totaling at least six credit hours.

This course also satisfies the New York State Skills Competency Requirement for Admission to the Bar. To satisfy this requirement, students must successfully complete 15 credit hours of practice-based experiential coursework.

Note 16: This course is intended for students enrolled in the JDinteractive program.

Note 17: This course meets the Cultural Competency/DEI Requirement.

Note 21: Clinic II - only open to students who have completed the basic clinic course in this specialty area. Enrollment is at the discretion of faculty member and is very limited. Variable credits between 1 and 4, as determined by faculty instructor before start of the semester.

Note 36: DIRECTOR OF EXTERNSHIPS APPROVAL REQUIRED FOR ENROLLMENT AND DETERMINATION OF CREDITS. Contact: lawexternships@syr.edu. This is a variable credit course, with a 2 credit minimum, based on hours worked (1 credit hour = 50 hours of placement work). Registration in 1 credit externship seminar is required.

Note 38: Course will not meet every week. Schedule will be disseminated by instructor.

Note 40: This course take place in London, UK, July 8-12. Pre-registration required. Students may elect to take this course for an optional 4th credit.

Note 41: LCR II – Students must successfully complete LCR II before enrolling in a Professional Writing Requirement course.

Note 60: LAW 800 in JDI may only be taken in the last two semesters of coursework.
