### KEY DATES

Applications and supporting material must be submitted no later than October 15, 2023. The scholarship winner will be notified via phone and email by November 15, 2023, and have the option of having the scholarship check mailed to them or sent directly to the financial aid office.

### SELECTION CRITERIA

Following the application deadline, essays and submissions will be reviewed and judged based on the following:

- Responsiveness to the question.
- Grammar and style.
- Originality and thoughtfulness.
